

ALL EXTERIOR PAINTING MUST HAVE WRITTEN APPROVAL FROM BOTH THE SUB-ASSOCIATION AND WINSTON TRAILS FOUNDATION, INC. INCLUDING FRONT DOOR OR GARAGE DOORS.

The color your home is currently painted may no longer be approvable. No one will be asked to repaint their home until needed just to comply with the new paint palette, however you will have to select from the new color palette when it is time to repaint. Paint color choices must still have ARB approval from Catalina on the Greens and Winston Trails Foundation. Your selection will be approved based on the color coordinating with your roof and driveway color.

In the available Winston Trails paint palette each color scheme has three or more options. There is one color for the body of the home, one color for the trim and one or two colors for an accent color. Each color is marked for the specific use.

Paint Manufacturer

Homeowners may select a color scheme and if they choose to use a different paint manufacturer than the original color scheme manufacturer, the homeowner must take a sample to the manufacturer of their choice and have the sample computer matched to the original sample.

The Body: The body of the home is considered to be everything that is not listed as trim. Inside enclosed patio walls are considered the body of the house.

The Trim: Trim is considered to be all decorative bands under windows, around the house, trim around doors and windows, on planters against the house, shutters and any decorative features attached to the house. Typically these are circle vents above the garage doors. Fascia boards are considered part of the trim of the house. The coordinating trim color on a color scheme is **OPTIONAL**. White or coordinating off-white color (as found in the Benjamin Moore Whites made easy brochure) may be used instead of the trim color. ARB approval is still required for the white trim. All homes must have a contrasting trim so the chosen white must be in significant contrast to the body color. There will be no "white on white" homes.

Accent Color: The coordinating accent color to the color scheme may be used on front doors and shutters only. No garage doors may be painted with the accent colors. Pedestrian garage doors or doors on the side or back of the home may not be painted with the accent color. Front doors may be painted the faux wood finish if no accent color is used. **Doors:** Doors are the garage door(s), front door(s) and all other doors on the exterior of the house.

Garage Doors: The garage doors only (not the trim surrounding the door) may be painted the body color.

Number of Colors: The maximum number of colors a house may be painted in Winston Trails is three.

No house may be painted the same body color of a house on either side of the subject house.

If you have a home that has been repainted or is not a Westbrooke home, your paint color may no longer be approvable. You will have to select from the new color palette. No one will be asked to repaint their home until needed just to comply with the new paint palette. Paint color choices must still have ARB approval from the sub association and Winston Trails Foundation. Your selection will be approved based on the color coordinating with your roof and driveway color.

In the available Winston Trails paint palette each color scheme has three or more options. There is one color for the body of the home, one color for the trim and one or two colors for an accent color. Each color is marked for the specific use.

Faux Stone: Some models have a faux stone wall in front of the house. If this area must be painted it must be painted so that the original look is maintained. Final approval will be at the discretion of the ARB Committee.

Accent Color: The coordinating accent color to the color scheme may be used on front doors and shutters only. No garage doors may be painted with the accent colors. Pedestrian garage doors or doors on the side or back of the home may not be painted with the accent color.

Doors: Doors are the garage door(s), front door(s) and all other doors on the exterior of the house.

Garage Doors: The garage doors only (not the trim surrounding the door) may be painted the body color, the trim color or if approved the garage door and front door may be painted an approved brown or faux wood treatment. If the garage door is brown or faux wood, no accent color may be used and the front must match the garage door in this case.

Number of Colors: The maximum number of colors a house may be painted in Winston Trails is three.

No house may be painted the same body color of a house on either side of the subject house.
